REGULAR BOARD OF ALDERMAN MEETING

Woodson Terrace City Hall Thursday, August 16, 2018

CALL TO ORDER

A meeting of the Board of Alderman of the City of Woodson Terrace was held on Thursday, August 16, 2018 at City Hall, 4323 Woodson Road. President of the Board, Mayor Besmer presided and called the meeting to order at 6:00 p.m.

Following roll call, City Clerk Ellie Crane reported a quorum was present. Also present were: Mayor Lawrence Besmer, City Administrator Doug Zaiz, Chief Butch Mayberry, City Collector Kyla Hill, Administrative Assistant John Conlon, Ricky Patel, Gene Norber, Andrew Ruben and members of the general public.

City Attorney Frank Vatterott invited the Board members to view the drop screens for a slideshow presentation.

Mr. Vatterott explained to the Board and audience how redevelopment occurs.

- A) A plan/project
- B) Community Improvement District
- C) Transportation District
- D) Development Agreement.

The project consists of a development area and developer.

The Board must agree that the area is blighted under §353 of the Missouri statute. There is no definition of blight. It is simply "a once functioning part of a community that needs to be updated to continue to be useful. "

The developer agrees to demolish and rebuild infrastructure and buildings. To recoup *some* costs, they are allowed by Missouri Law to create taxing districts.

CITY OF WOODSON TERRACE Board of Alderman Meeting Page 1 of 8 The district is made up of the redevelopment area, in this case, a new hotel. These districts have a decision making board, and the city has one seat on that board.

The first district is known as a Community Improvement District, or CID. To encourage development, Missouri law allows this district to collect "a tax", in this case 1% of the room cost, per room/per night, collected from the guests of the hotel. This is put in place by ordinance.

The second is a Transportation Development District or TDD. This allows the developer collect "a tax" on this district. In this case, 1% of the room cost, per room/per night. This is created by court order.

The developer also has asked for a Special Assessment of \$4.00 per night, per room, as an additional incentive.

The last part is the Development Agreement. This is made between the City and the Developer and it outlines expectations of each party.

This includes any tax abatement. Tax abatement reduces the amount of property tax owners pay on new construction, rehabilitation and/or major improvements. In this case, 12.5 % of the taxes due OVER the existing taxes are abated. Currently, the taxes are \$413,760. This means the developer pays \$413,760 in Real Estate tax per year, plus any new taxes, minus 12.5%. This abatement has been approved for 10 years.

In order for any of this to take place, the other taxing districts in the area must agree. Attorney Andrew Ruben contacted these entities in regards to the upcoming public hearing about these items, including schools and fire districts. None of these entities were present.

At this time, the Mayor asked for a motion to suspend the meeting to start the public hearing.

Alderman Greg Mills made the motion, seconded by Alderman Donna Conlon.
