REPORT OF **COMMITTEES**  City Administrator Doug Zaiz reported that OHM project is going back to Planning and Zoning on 8/27/19 to reapply for some zoning districts. Best Western Plus has completed Architectural review has started construction. He also stated he would be representing Woodson Terrace at the annual MIRMA conference later this month.

**Public Works** 

City Clerk Ellie Crane reported the court total of \$9,170.00 for July. She also shared there would be a newsletter out in August, and an election the first Tuesday of August.

City Attorney Frank Vatterott reported that he represented the City at MMAA Conference. They discussed many things, among them property maintenance issues.

He also stated that a Public Hearing on the Airbnb topic would take place August 27.

Municipal courts are being moved to a unified system. REJIS, the primary provider for most courts in Missouri, is slowly bringing things online.

Mayor Besmer reported the city has had some calls and a Realtor dropped by regarding Missouri's legalization of Medical Marijuana. We will need to tackle this issue soon.

Alderman Zaiz shared that the Playground and Path at the park are progressing. The soil issue has been solved and all retaining walls are finished. The path behind Refuge Center church will also be poured in this project.
