OPEN FORUM FOR	At this time, Mayor Besmer opened the meeting to comments of citizens.
CITIZENS	Resident Chris Mueller (4435 Lindscott) produced a "Vote no one the merger" yard sign,
	and feels that everyone was working together better when the merger legislation was
	active. Now that it has been pulled, it does not seem as if neighbors are helping neighbors
	anymore.
	Resident Marilyn Flatly (4205 Beauty Lane) felt a disservice was done to Dan McFarland
	when he passed. She feels the city should have promoted his services more.



	Also, Neighborhood Watch is not meeting regularly, and feels it should be removed from the Marquee if its not going to meet. Also, it's difficult to hear in the meetings because they have no sound system.
REPORT OF OFFICERS Chief of Police	Chief Mayberry shared Detective Lt Dan Hunter has resigned. They have 2 strong candidates from the last round of interviews.
	Additionally, the suspect in the April 2017 Tutwiler shooting was convicted of Assault 2nd an Armed Criminal Action. His sentencing is in the near future.
	Recently a grand jury returned a true bill on 18 counts of burglary that occurred in the area.
	On October 18, there was a robbery at the Airport Inn. The suspect had left behind a coffee cup behind and was identified through DNA testing.
Collectors Report	No report
City Administrator	City Administrator Doug Zaiz reported the pool is finally squared away. New grates and filters were installed and the pool is running smoothly.
City Clerk	City Clerk Ellie Crane reported the court total of \$8,513.50 for June.
City Attorney	Frank Vatterott briefly summarized the legislation on the agenda. There is a bill to create a Mirma health insurance pool, an Ordinance to adopt the budget, and to appoint special Planning and Zoning counsel.
	Additionally, he shared that many municipalities are passing legislation on the Medical Marijuana dispensaries and growing operations, effectively zoning it out of their area.
	Also, he has rewritten a few areas on the AirBnB ordinance for Planning and Zoning to take another look at.
Alderman Comments	Alderman Willey noted there was another loud party and wondered if they should call the police. Yes, they should call per Chief.
REPORT OF COMMITTEES	There have been several issues with the pool this season. Pools Unlimited closed unexpectedly, leaving us without guards. When it did open after the anticipated start date, a filter malfunction ensued and drained the pool. It took several weeks to repair, as Westport pools was servicing us,
Public Works	their own clients, and everyone else Lifeguards Unlimited let down.
	Now, all filters and drains have been replaced, and the pool is running efficiently.
	The parking lot at the top of the hill has hit a few snags. They had to call on an engineer to look at some things after they ran into some bad soil.

Budget, Job and Wage

Alderman Hogan reported that The Budget, Wage and Job Study committee met June 13. They were joined by the HIC agency and given updated insurance proposals. The selfinsurance works differently, but the fund the city pays into covers an upfront per person. By increasing that slightly, the cost could lower and keep more money in the fund. The committee recommends this and Alderman Hogan made the motion to accept this higher "laser", seconded by Alderman Mills.
