After joining, you will be placed in a virtual lobby until the clerk checks you in. It works just like "in-person" you are in a <u>Virtual Line</u>. It is possible to wait in the court room sometimes an hour or more; depending on the size of the docket, how many charges each person has, what those charges are, etc. It may take a while until the host admits you. Please be patient.

PLEADING GUILTY WITHOUT A COURT APPEARANCE

If you wish to plead guilty as charged <u>before</u> this Court date, <u>please</u> see the attached fine and cost list for applicable offenses, or at www.woodsonterrace.net.

Your payment of your citation constitutes a plea of guilty to the offense charged on the citation and a waiver of your rights of appearance and trial. The Dept. of Revenue will assess points against your driving record as required by law for any offence (e.g. moving violations) that carries points; (https://dor.mo.gov/forms/899.pdf)

If you can pay your fines and costs online go to www.courts.mo.gov/casenet (enter case#, then click Plead and Pay), if it is not there, go to the older system www.ipaycourt.com. Other options are to pay by mail or in person at the Court Building. Not ALL charges are applicable, if your charge is not on the list you MUST appear.

FAILING TO APPEAR

This is an actual court hearing for which you are scheduled. Failure to appear for your court proceeding via Webex or In-Person, may result in a warrant for your arrest or a hold being placed on your license.
