#### APPROVAL OF MINUTES

Chairman Mills asked for a motion to approve the minutes from the March 13, 2025, meeting. Alderman Martin made the motion, seconded by Alderman Zaiz. With a unanimous decision motion passed.

#### POOL & CAMP COMPENSATION

City Administrator Doug Zaiz presented Bill 2226 to increase the pay for pool and camp employees as it has been a few years since there last raise.

## **PUBLIC WORKS**

Mayor Besmer presented to the Board the costs to purchase a Christmas Tree for the Park. The total cost to purchase a 10–11-foot Norway Spruce from Schmittel’s Nursery with a one-year warranty and installation is \$1,345.00

Chairman Mills entertained a motion to recommend to the Board approval to spend \$1,345.00 to purchase a Christmas Tree for the Park. Alderman Zaiz made the Motion seconded by Alderman Martin. With all in favor motion carried.

With nothing further Chairman Mills called for a motion to Adjourn, Alderman Martin made the motion seconded by Alderman Zaiz. With a unanimous vote the meeting ended at 7:43 p.m.
